DUTIES AND RESPONSIBILITIES

UN Tourism is the United Nations agency responsible for the promotion of responsible, sustainable and universally accessible tourism.

UN Tourism is currently looking for a **Senior IT Specialist (Financial System Maintenance Support)** for its **Information and Communication Technologies Department**.

The **Information and Communication Technologies Department** is responsible for providing technological services and technical support to the Organization and in the IT and communications fields (email, intranet, micro computing, applications, network, etc.).

Under the supervision of the Manager, Information and Communication Technologies Department, the incumbent will:

1. Independently resolves incidents generated by users of the financial and other electronic platforms and systems of the Organization and generates relevant documentation; provides overall support to users in all matters related to these platforms and systems;
2. Regularly participates in department meetings as well as meetings with users of the electronic platforms and systems of the Organization, to assess these and manage related incidents; provides relevant follow-up;
3. Prepares and generates a variety of reports according to the needs of the department;
4. Collaborates with the Database Administrator (DBA) responsible for system infrastructure, to ensure the appropriate maintenance and implementation of changes;
5. Develops high-level product specifications with attention to system integration and feasibility;
6. Defines and implements all aspects of relevant systems development based on appropriate technology and workflow, in accordance with coding standards;
7. Ensures that the software of the financial and other electronic platforms and systems meets all requirements of quality, security, modifiability, extensibility, etc. and approves final product before launch;
8. Collaborates with other IT members in analyzing and developing new features, modifications and modules related to the financial and other electronic platforms and systems;

9. Proposes continuity plans for the financial and other electronic platforms and systems on the basis of comprehensive analysis, and provides relevant recommendations;
10. Lead the continuous review of the current financial system, as an acting project coordinator, in direct coordination with the ICT Manager. Reviewing all the feasible options for the organization and creating an appropriate proposal for the continuity or change of the financial system.
11. Performs other duties, as required.
